Is there an additional cost?

Yes, a Joint membership has a slightly higher subscription rate than a Single membership. By completing the form opposite you are consenting to pay an increased yearly subscription rate[†] to reflect the change from a Single to Joint membership.

What is a Joint Member entitled to?

The new Joint Member is entitled to all the same benefits and services as a Single Member, as detailed above.
