The National Federation of Occupational Pensioners is a company limited by guarantee, known as NFOP. On joining you will become a non-voting member of the company. To show that you have met any possible liability as a member, £1 from your first year's subscription will be allocated to the Members Guarantee Reserve. This amount is not repayable.

Data protection: The NFOP will record the personal information contained in your application on computer and use it to administer your membership, which will include contact with your pension provider if paying by deduction from pension. The data may be shared with a local branch of your choice but never to third parties, other than in order to distribute your magazine and other information to you from us. The information may be used for fraud prevention or money laundering prevention. By applying for membership you consent to our processing your personal data, for the above purposes. You have a right to ask for a copy of your information and to correct any inaccuracies. When you give us personal information about another person we will assume that they have appointed you to act for them and have consented to the processing of their personal data including sensitive personal data. We may contact you by mail, telephone, SMS, fax or email to let you know about any goods, services or promotions which may be of interest to you. The Direct Debit Guarantee

- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit the NFOP will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request the NFOP to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by the NFOP or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
 - If you receive a refund you are not entitled to, you must pay it back when the NFOP asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

Eligibility

An eligible member is classed as an existing member of NFOP who currently holds either a Single or Joint membership.

Depending on what stage of your life you have reached, your parents, children or grandchildren could benefit from joining NFOP. By joining as a family member they will receive all the benefits at a reduced cost.

*Individual membership is £21.00 and Joint membership is £31.80. The difference being £10.80.
